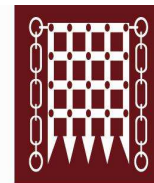

9.10 - 10.00 **Raising standards for children in care: improving mental health provision, educational attainment and children's residential care**

*In light of evidence that children in care are four times more likely to experience mental health difficulties, what should be the next steps for improving mental health provision for looked after children? What more can be done to reduce the educational attainment gap between looked-after and non-looked after children? What training and support will be needed to maximise the impact of the new requirement for schools to appoint a staff member as responsible for the attainment of children previously looked after? How can children in care be supported to overcome past trauma and build trusting relationships; what should be the role of care planning in this process? Following the Narey review's finding that places in children's homes are often 'bought' rather than commissioned, how can commissioning practice in children's residential care be improved; will the establishment of the Residential Care Leadership Board help? How can children's social care establishments prepare for Ofsted's new social care common inspection framework, introduced in April 2017? In light of reduced oversight of children's homes rated 'good' or 'outstanding' from April 2017, what safeguards are necessary to ensure that quality of care is not negatively affected?*

11.55 - 12.55 **Improving support for care leavers: the care leavers' covenant and easing the transition to adulthood**

*How can local authorities best implement the new requirement that local authorities publish a 'local offer' to care leavers and provide a personal adviser until the age of 25; what can be done to ensure that knowledge of services reaches as many care leavers as possible, and what examples of best practice exist? In light of renewed funding for the Innovation Programme, what lessons can be learnt from evaluations of projects to support care leavers and what should be the priorities for the future of the programme? What action would be required to enable care leavers to have access to CAMHS until the age of 25, as suggested by the Education Select Committee? What lessons can be learnt from the 'Staying Put' programme as the 'Staying Close' initiative is trialled to ease the transition to adulthood of children living in residential care, and what further support is needed for care leavers who choose other routes out of care? What are the main barriers to care leavers applying to, and attending, higher education institutions, and how can these be overcome? For care leavers who choose not to attend university, how can they be best helped with entering other forms of education, training or employment?*
