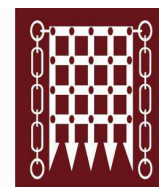

In light of the Higher Education and Research Act encouraging universities to offer more accelerated or flexible courses, what is the likely take-up amongst universities and students, and impact on access, academic success and social mobility for students? What is the demand for two-year degrees amongst employers? How can two-year degrees effectively be regulated, including with regard to the higher fee cap? How should HEIs approach dealing with the challenges of offering accelerated and flexible courses, for instance in the use of facilities outside the traditional academic calendar, the creation of new assessment arrangements and issues surrounding academic and non-academic staffing? What are the implications of accelerated degrees on sandwich courses and similar, or on the development of student's academic skills such as writing and on the overall student experience? Will two-year degrees also impact the postgraduate market as universities can offer a 'three-year' degree including a masters degree, particularly in light of the introduction of PGT loans?
