What are the challenges and opportunities HWBs face in developing joint commissioning and pooled budgets? Is the budget of £5.45 billion for public health adequate to protect resources over the next two years? What steps can be taken to ensure that ring-fencing the budget doesn't create barriers or block integration? How big a role should deprivation play in determining the level of core NHS funding a local area receives? With the health premium due to be introduced from 2015-2016, should more be done to address fears that it will incentivise poor performance, and to ensure that areas that need money most will not lose it? Should the objectives for public health be defined by Public Health England (PHE), locally, or should there be a balance? How should the progress indicators in the Public Health Outcomes Framework be used to inform commissioning of public health services? Is the new structure of commissioning providing an opportunity for the voluntary and private sectors to get more involved with impact assessments and service provision? How can pharmacies help to spearhead public health and wellness activities? How can PHE and NHS England work best with HWBs and local authorities to deliver their public health duties?
