Will Government's proposed reforms succeed in tackling the structural causes of 'grade inflation' and improve the university, employer and public perception of A-levels? Will the greater involvement of Russell Group universities in the development of A-level curriculums better prepare students for the transition for university? Should non-Russell Group universities and employers be involved in the development of A-levels? Would the proposed move away from modularisation and AS-levels, towards a more linear approach with exams sat at the end of 2 years study, be the best model for all subjects, or should the structure be more flexible to fit the specific needs of each subject? Could the removal of modules and AS levels have a negative impact on efforts to widen participation in Higher Education? What would be the likely impact of proposed limits on the number of re-sits that can be taken? Has the A* grade been effective in helping universities differentiate the most talented pupils? Should the A* grade be awarded only to a fixed percentage of top students, and if so, would this aid universities and employers in identifying top performers?

Will the introduction of 'more rigorous' multiple choice questions, combined with the removal of modularisation and AS Levels, encourage schools to teach a greater breadth of subject knowledge and not 'teach to the test' as Government suggests? Do current Alevels adequately prepare students for the analytical researching skills required at undergraduate level? Should the study of Maths and English be compulsory for A-level students, and if so, what form should this take? Would a structure for Key Stage 5 learning more akin to the International Baccalaureate or Welsh Baccalaureate - with wider skills being assessed alongside the specific subjects - improve the university/employment-readiness of students? What is the future role for General Studies? Should A-levels be purely academic or contain vocational elements and work-based learning? Should universities be required to publish the list of A-levels which are 'not preferred', and should the range of subjects available at A-level reflect these preferences?
