## The Early Years Foundation Stage: 'school-readiness', training challenges, and supporting disadvantaged pupils

What has been the impact so far of the reformed Early Years Foundation Stage (EYFS) in preparing children with the social, emotional, behavioural and communicative skills needed for the transition to formal education? What will be the likely impact of removing the statutory requirement for all providers to complete a EYFS Profile for all children? What form will the proposed new 'baseline assessment' for all pupils when they reach Reception class need to take in order to be a more effective tool for accurately identifying children's ability and further developmental needs? Are current flexibilities around entry dates into Reception sufficient to accommodate children at a lower level of development; could these freedoms be extended to address concerns around the 'school-readiness' of summer-born pupils? How valid are concerns around children entering Reception with very low levels of development, including not being toilet-trained? How can primary schools use the Pupil Premium to support disadvantaged pupils with low levels of development, particularly those without a statement of Special Educational Needs? What impact will extending the Pupil Premium to early years have on supporting children from disadvantaged backgrounds?
