How well have music hubs addressed the initial concerns of Ofsted, such as not working closely enough with schools, and what steps are being taken to ensure greater collaboration; to what extent are hubs providing 'value for money'? Will the new Music GCSE address gaps in theoretical and conceptual understanding, and what more should be done to tackle pupils' low expectations? Has the counting of music exams passed at grade 6 or higher in GCSE league tables increased the number of pupils taking up the subject? How valid are concerns of a skills shortage amongst music educators and how successful have the Certificate for Music Educators and Initial Teacher Training add-on modules been in boosting teachers' skills and confidence? What has been the impact of the Musical Futures movement, which supports and develops high-quality music teaching, particularly its 'champion teachers' programme?
