#### 11.50 - 12.30 Developing fit-for-purpose primary care premises: finance, infrastructure and new models of care

In light of reports of potentially one in ten GP practices being hazardous to health and unfit for purpose, what should be the way forward for ensuring that GP practices, and other primary care settings are up to standard? What more needs to be done to adapt estates to provide new models of care and the NHS Vanguard sites? With the availability of WiFi in NHS premises cited by many as a priority, what are the practical and cost challenges for implementation and how should they be addressed? Should more be done to protect funding from the Primary Care Transformation Fund (PCTF) and to make sure that funding is not used to cover financial shortfalls in other aspects of services? How will changes requiring GP practices to seek CCG approval for improvements to estates impact the improvement of primary care estates? What steps need to be taken to ensure that estates remain fit for purpose under proposed GP mergers to create 'super mergers?' What impact will the increase in management charges by NHS Property Services to maintain estates have on GP premises?
