With NICE currently working on new guidelines on safe staffing, is enough being done to ensure safe levels across healthcare, and what examples of best practice exist in safeguarding patient safety? Following concerns that the UK health and care complaints system is 'bewildering' for patients, what steps should be taken to provide greater clarity and improve engagement? With NHS England and the Medicines and Healthcare Products Regulatory Agency working together on the redevelopment of the National Reporting and Learning System, what further opportunities exist for using integrated reporting of incidents to improve outcomes for patients? Following the launch of 'Freedom To Speak Up' review into reporting culture in the NHS, what more should be done to encourage NHS staff to raise concerns in order to help inform better practice in the future?
