What does the future hold for grammar schools in light of the Government proposals to allow existing grammar schools to expand and new ones to be opened to meet local demand? In what ways can new and selective schools wanting to expand collaborate with local authorities and existing local non-selective schools to meet the requirements for expansion and opening up new selective schools? Given the anticipated rise in the number of new faith school following the proposals in the Education Green Paper to allow new faith schools to select up to 100% of pupils based on their faith; what would be the role of faith schools in a diverse school system? In light of concerns expressed by a range of policymakers about Government's goal, outlined in the Education White Paper and the Queen's speech to create a school-led system with schools working towards becoming academies, what changes to policy would school leaders and others in the sector regard most worthy of consideration? How can the Government address concerns raised by school leaders about the need to reduce the cost of academy conversions to make it more affordable for schools? What could be done to support small primary schools and schools in rural areas to convert into academies amidst concerns about their lack of capacity to do so? In what ways can local authorities, schools, and academy trusts work together to minimise any disruption to provision ahead of the anticipated rise in the number of faith schools and selective schools in light of the proposed reforms in the recent education green paper?

What steps can they take in order to increase their overall transparency and accountability?
