

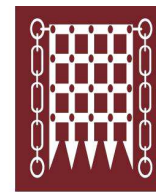

*At a time when Ofcom has confirmed a consultation on higher bands above 26GHz, as well as looking at the bands already available (700MHz) and soon to be (3.4 - 3.8 GHz), is enough being done to ensure that spectrum is made available for 5G in a timely way? What will be the implications for other users in these bands, particularly satellite, and how can their access to spectrum be protected whilst not impeding progress for 5G? What is the appetite for investment in network development of 5G, and how does thinking vary among industry players on timing and further 4G rollout? What might be the short and long term impacts of the Brexit vote for spectrum policy in the UK? In the short term, how closely does UK and EU thinking align on the development of 5G, and in the longer term, beyond 5G, where does the UK stand in future policy discussion? How in practical terms could increased UK autonomy post-Brexit be used for new approaches or competitive advantage, or will it be more prudent to continue to act in a more harmonised way internationally?*
