## 9.40 - 10.40 Addressing the challenges of teaching British values in schools

Was the brief on 'British values' given to schools sufficient to enable implementation; what further clarification is needed to enable schools and colleges to better embed them in everyday practice? How has the result of the EU referendum - and the five-fold increase in reported hate crime that followed it - impacted on schools' work to promote British values? How can schools and colleges go about promoting British values as part of students' spiritual, moral, social and cultural development with minimal disruption; should they be built into existing arrangements such as citizenship lessons? Following concerns that subjects such as PSHE and RE are increasingly overlooked in favour of EBacc subjects, what can be done to ensure that their potential contribution to promoting British values is protected and enhanced? What more can be done to promote open debate and discussion around British values within communities; how best can schools and colleges engage parents and community groups in this discussion? What should be the role of religious organisations in promoting British values in schools? How can the teaching of British values be tailored to areas with varying demographics and needs?
