



# Having a say



What's happening? As part of the Council's Regeneration Programme, the shopping centre and some surrounding buildings are being demolished to make way for a new civic square, shops and flats. North Edinburgh Arts will remain.

When is it happening? The first phase of construction is about to get underway. The existing shopping centre will Late 2018 - Shops and homes on Pennvwell Road be demolished in phases to ensure that as many shops as (nos 51 to 61) will be hoarded off and demolished. possible can stay open during the redevelopment. The project is expected to last around four years.

How will this affect me? Please see plan overleaf.

### PHASE 1 August/ September 2017:

## constructing of a secure compound area for site

accommodation (see contractor's compound on plan) Hoarding put up around section of the shopping centre to be demolished. (outlined in red on plan).

## Oct 2017

Demolition of shops within hoarding will start.

## Nov 2017

Construction of three new retail units and 12 new homes within the area hoarded off will start. This will complete late 2018. Shops will open and people will move into new homes

-Shops in green not affected by phase 1

-Art centre and library open for business as usual

-Access through the existing shopping centre will be maintained at all times.



-Clear panels will be used as part of the hoarding to allow as much light as possible to come into the temporary walkways. CCTV coverage will be maintained throughout construction and improved as part of the completed project. Please see plan overleaf

## FUTURE PHASES

40 new homes and 8 retail units will be built. These shops will open and people will move into new homes.

Late 2020 - Shops and homes on Pennywell Rd (no's 39 to 47a) and Pennywell Court (no's 1-13) will be demolished. 96 homes and 3 new shop/ office/ retail units will be constructed on this site. There are also plans to demolish the library and build a new building with the library and services within this block. Timescales are yet to be agreed for this.


Who is carrying out the work? The City of Edinburgh Council has appointed Robertson Partnership Homes as the main contractor.


